- Multiple investment choices. You can invest in vehicles that range from potentially high growth to highly conservative, so you can make the most appropriate choice to help you meet your savings goals.
- Simple investing with GoalMaker. GoalMaker® is an optional, easy-to-use asset allocation program available at no additional cost that automatically guides you to an age-appropriate investment mix based on your investor style.
- Quarterly statements to keep you informed.
- Online retirement planning tools. You may access your account 24 hours a day, 7 days a week. You may also access a host of retirement articles, interactive calculators and other resources at NCPlans.prudential.com.

MUNIS SELF SERVICE

I am happy to report that MUNIS Self Service is operational again. If you go to the County's website, on the human resources page under employee information, there is a link under quick links that says Munis Self Service. Click that link. In the upper far right hand corner of the dark blue bar is an arrow. Click the arrow. That takes you to the login screen. Your user name is your first initial, last name plus last four of your social. For instance mjohnsonxxxx is mine with the xxxx being the last four of my social. If you have never logged in, your password should be last four of your social. The employee self service page shows your leave balances and your personal information. The pay/tax information tab shows a history of your pay notices and your W2s and has some links at the bottom. Check it out. It's a great resource for you.
