## Cherokee County Board of Commissioners Budget Worksession June 3, 2020 5:30 P.M. Cherokee County Courthouse

Call to order and Ethics Statement by Chairman

Invocation and Pledge

911 Dispatch, Sheriff's Office and Detention Center Budget Discussion

Chief Deputy Wood said that most of the department's request has stayed the same as in past years, with the exception of the radio communications improvement project. Representatives from Mobile Communications of America came before the board to present the project; along with representatives of Infinity Tech Solutions, and Motorola. Todd Robinson, engineer for Infinity Tech Solutions shared a PowerPoint and explained how the proposed project would improve and enhance communications for Cherokee County 911. The project would address current radio issues and greatly improve response times. Theresa Creasman, 911 Dispatch Supervisor, was also present and discussed the current radio situation and said that the communication upgrade would solve the issues that have been recently discussed.

Chief Deputy Wood discussed the Sheriff's budget request for patrol vehicles, saying those to be replaced have an average of 180,000 miles.

Jail Administrator, Shon Crisp, shared the need of a transport vehicle for involuntary commitments, and also the need to replace the detention centers current plumbing system with a remote system and the need to replace multiple plumbing fixtures. He said maintenance cannot get repair parts and fixtures, because the parts were almost obsolete when the detention center was built. Also discussed was the servicing of all the jail door locks, and the need for roof repairs. Cox Roofing has submitted a quote. Commissioner Dickey, former maintenance director, said he, nor Wells and West, and no one else has been able to solve the roof issue.

## Additional Budget Discussion

The finance director shared a fund balance report. The County Manager discussed the need to adjust the counties pay plan. He said he had originally intended to include it in his recommended budget, but when the Covid pandemic hit, and not knowing what the financial impact to the budget will be, he did not include it. He also discussed Cherokee County Schools budget request

and how that request could impact county services and/or result in the need for a tax rate increase, should the board choose to fund the full request.

## Adjournment

There being no further business, a Motion was made by Commissioner Westmoreland to adjourn. Motion seconded by Commissioner Stiles. Motion passed unanimously.
