#### **MEETING MINUTES**

#### June 21, 2023

#### I. Call to Order

The regular meeting of the Cherokee County Department of Social Services was duly held on June 21, 2023, at 12:00 P.M. at 4800 West Highway 64, Murphy, N.C. 28906.

Director McGee called the meeting to order at 12:00 P.M., and Amanda Rhodes, Clerk to the Board recorded the minutes.

## **Modification of Agenda**

Director McGee requested for the "Foster Parent Complaint" section be moved to the end of the meeting and to include a closed session. and also requested for the "Legislative Update" section be removed from this Agenda. Mrs. Ivie made a motion to modify the agenda as requested, with Mrs. Carter seconding the motion, with all in favor.

# IV. Approval of the Minutes

Director McGee requested for the Board to defer the minutes to the next scheduled DSS Board meeting as there were no minutes available at the time of this meeting. Mrs. Ivie made a motion and Mrs. Carter seconded the motion, with all in favor.

## V. Cottage for the Children Update

Director McGee informed the Board that the front and back decks at the Cottage have now been completed and the water and power are hooked up. Once a final inspection is completed, the Cottage will receive a certificate of occupancy and will be accessible. Director McGee discussed having internet access at the Cottage for cameras and security.

## VI. One-Home Update

Director McGee provided a brief overview of the One Home Project and the recent changes that have taken place. Since the One-Home Project's change in ownership, the expected cost of the One Home service increased to approximately \$100,000 per year. Director McGee informed the Board that the One Home services would be too expensive for the Department to continue to partake in.

## VII. Adult Services Update

Adult Protective Services Supervisor, Daunita Maennle discussed the crisis regarding the Adult Protective Services. Since January, 2023, the APS unit has received an influx of reports regarding the younger generation experiencing mental health and/or substance abuse related issues. As a result of such reports, there is an increase in cases requiring Court involvement which contributes to larger caseloads for the social workers.
