



AGREEMENT FOR ABANDONED & CUSTODIAL SERVICES BY AND BETWEEN THE VALLEY RIVER HUMANE SOCIETY AND CHEROKEE COUNTY, NORTH CAROLINA

THIS CONTRACT AND AGREEMENT is made and entered into between the Valley River Humane Society, Inc., a non-profit corporation established under the laws of the state of North Carolina (hereinafter "VRHS") and Cherokee County, North Carolina, a body politic and political subdivision of the State of North Carolina (hereinafter, "County") and referred to collectively as "parties" for purposes of the agreement contained herein.

WHEREAS, Cherokee County has appointed the Sheriff of Cherokee County as its animal control officer.

WHEREAS, the Cherokee County Health Director possesses duties under state law regarding rabid and vicious animals.

WHEREAS, in the course of execution of the duties of a Health Director, Animal Control Officer, and as law enforcement officers it becomes necessary to seize and provide for the boarding and care of certain animals.

WHEREAS, the laws of the State of North Carolina provide for the ability of a county government to contract with non-profit organizations for services that serve a public purpose.

WHEREAS, VRHS has offered an animal shelter in compliance with the North Carolina Animal Welfare Act and the corresponding regulations of the North Carolina Department of Agriculture including, but not limited to, 02 NCAC 52J, et al.

WHEREAS, it serves a necessary public purpose for the citizens of Cherokee County to have a repository for unwanted or abandoned domesticated animals.

WHEREFORE, Cherokee County and the Valley River Humane Society, Inc. enter into this agreement in consideration of the covenants and consideration herein contained and the services to be performed by the parties, the parties hereby contract as follows:

- Scope of Work: VRHS shall accept all such animals tendered unto to it by the Cherokee County Sheriff's Office, the Cherokee County Health Department or any other department of Cherokee County Government.
- 2. Term: This contract shall be effective on July 1, 2025 and terminates at 11:59 p.m. on December 31, 2025.
- VRHS shall accept from any citizen or resident of Cherokee County any stray or unwanted animals tendered unto VRHS.
- 4. VRHS shall maintain sufficient capacity to house animals seized as evidence by law enforcement agencies and animals submitted to VRHS by the Cherokee County Animal Control officer and shall maintain such space as to facilitate quarantined animals as may be ordered by the Cherokee County Health Director.
- 5. VRHS shall fully indemnify and hold harmless the County, the Cherokee County Health Department and the Office of the Cherokee County Sheriff from all claims, demands causes of action and judgments arising from any act, failure to act or negligence of VRHS, its employees, volunteers, contractors or agents. Indemnification of the County, the

- Health Department and the Office of the Cherokee County Sheriff shall survive the termination or lapse of this contract.
- 6. The VRHS shall comply with all applicable laws and regulations including but not limited to federal, state and local laws regarding business permits, certificates, and licenses that may be required to carry out the services to be performed under this Agreement and all federal immigration laws in its hiring and contracting practices. VRHS and its subcontractors shall comply with Article 2 of Chapter 64 of the North Carolina General Statutes relating to the required use of the federal E-Verify program to verify the work authorization of newly hired employees. Failure of VRHS to comply with this provision or failure of its subcontractors to comply could render this contract void under North Carolina law. VRHS hereby certifies that it is not on the North Carolina State Treasurer's lists of persons engaging in business activities in Iran or boycotting Israel, prepared pursuant to NCGS §§ 147-86.58 or 147-86.81, nor will VRHS utilize for this Agreement any subcontractor on such lists. This agreement is intended for the benefit of the County and the VRHS and not for any other party. If any provision of this Agreement shall be unenforceable, the remainder of the Agreement shall be enforceable to the extent allowed by law.
- 7. VRHS shall make provisions and take all necessary actions to modify and improve methods through which animals may be adopted from VRHS.
- 8. Notwithstanding anything to the contrary herein, in the event that public funds are unavailable and not appropriated for the performance of the County's obligations under this Agreement, then this Agreement shall automatically expire without penalty to the County 30 days after written notice of the unavailability and non-appropriation of public funds. In the event of a change in the County's statutory authority, mandate, or mandated functions by state or federal legislative or regulatory actions, which adversely affects the County's authority or duty to continue its obligations under this Agreement, then this Agreement shall automatically terminate without penalty to the County 30 days after written notice of such limitation or change in the County's legal authority or duty.
- 9. VRHS shall submit itself to annual audits of all of its financial records and accounts (including all revenues and expenses) by a certified public accountant. Reports prepared by the auditor shall be submitted to the Cherokee County Chief Financial Officer within 30 days of completion by the auditor and no later than 60 days before the end of the County's fiscal year(June 30).
- 10. VRHS shall submit, upon request of the Cherokee County Chief Financial Officer any and all financial and inventory (inert and living) records as the County deems fit to ensure responsible use of taxpayer funds.
- 11. VRHS shall maintain all registry and tax returns as required by the Internal Revenue Service and the NC Department of Revenue, including, but not limited to, IRS Form 990 (Return of Organization Exempt from Income Tax). The IRS Form 990 shall be submitted to the Cherokee County Chief Financial Officer upon filing.

- 12. Billing: VRHS shall submit monthly invoices to the Chief Financial Officer electronically to finance@cherokeecounty-nc.gov for all canines and felines subject to this contract.
- 13. The county, in consideration of services provided as set forth herein, shall tender unto VRHS the amount of \$_____ to be distributed by the 15^{th} day of each calendar month.
- 14. Except as otherwise stated herein, the County may terminate this contract by giving 30 days' notice to VRHS in writing. Refusal to accept any canine or feline tendered under this contract shall be a breach and subject this contract to immediate termination and no further payments to VRHS by the county.
- 15. This contract contains the entirety of the agreement between the parties. All prior proposals, negotiations or discussions are merged herein or intentionally omitted. This Agreement is binding upon, and shall inure to the benefit of the parties themselves, as well as their respective representatives. No other promises or consideration form any part of the parties' agreement.
- 16. The parties agree that time is of the essence in all elements of this agreement.
- 17. AGREEMENT FOR ABANDONED & CUSTODIAL SERVICES BY AND BETWEEN THE VALLEY RIVER HUMANE SOCIETY AND CHEROKEE COUNTY, NORTH CAROLINA

THIS CONTRACT AND AGREEMENT is made and entered into between the Valley River Humane Society, Inc., a non-profit corporation established under the laws of the state of North Carolina (hereinafter "VRHS") and Cherokee County, North Carolina, a body politic and political subdivision of the State of North Carolina (hereinafter, "County") and referred to collectively as "parties" for purposes of the agreement contained herein.

WHEREAS, Cherokee County has appointed the Sheriff of Cherokee County as its animal control officer.

WHEREAS, the Cherokee County Health Director possesses duties under state law regarding rabid and vicious animals.

WHEREAS, in the course of execution of the duties of a Health Director, Animal Control Officer, and as law enforcement officers it becomes necessary to seize and provide for the boarding and care of certain animals.

WHEREAS, the laws of the State of North Carolina provide for the ability of a county government to contract with non-profit organizations for services that serve a public purpose.

WHEREAS, VRHS has offered an animal shelter in compliance with the North Carolina Animal Welfare Act and the corresponding regulations of the North Carolina Department of Agriculture including, but not limited to, 02 NCAC 52J, et al.

WHEREAS, it serves a necessary public purpose for the citizens of Cherokee County to have a repository for unwanted or abandoned domesticated animals.

WHEREFORE, Cherokee County and the Valley River Humane Society, Inc. enter into this agreement in consideration of the covenants and consideration herein contained and the services to be performed by the parties, the parties hereby contract as follows:

- Scope of Work: VRHS shall accept all such animals tendered unto to it by the Cherokee County Sheriff's Office, the Cherokee County Health Department or any other department of Cherokee County Government.

 - 2. Term: This contract shall be effective on July 1, 2025 and terminates at 11:59 p.m. on December 31, 2025.

3. VRHS shall accept from any citizen or resident of Cherokee County any stray or unwanted animals tendered unto VRHS.

4. VRHS shall maintain sufficient capacity to house animals seized as evidence by law enforcement agencies and animals submitted to VRHS by the Cherokee County Animal Control officer and shall maintain such space as to facilitate quarantined animals as may be ordered by the Cherokee County Health Director.

VRHS shall maintain sufficient capacity to house animals seized as evidence by law enforcement agencies and animals submitted to VRHS by the Cherokee County Animal Control officer and shall maintain such space as to facilitate quarantined animals as may be ordered by the Cherokee County Health Director. Refusal to accept animals tendered by law enforcement officials or the Cherokee County Animal Control Officer or the Health Director shall be grounds for immediate termination of this agreement and the immediate termination of any and all payments by the County to VRHS.

5. VRHS shall fully indemnify and hold harmless the County, the Cherokee County Health Department and the Office of the Cherokee County Sheriff from all claims, demands causes of action and judgments arising from any act, failure to act or negligence of VRHS, its employees, volunteers, contractors or agents. Indemnification of the County, the Health Department and the Office of the Cherokee County Sheriff shall survive the termination or lapse of this contract.

The VRHS shall comply with all applicable laws and regulations including but not limited to federal, state and local laws regarding business permits, certificates, and licenses that may be required to carry out the services to be performed under this Agreement and all federal immigration laws in its hiring and contracting practices. VRHS and its subcontractors shall comply with Article 2 of Chapter 64 of the North Carolina General Statutes relating to the required use of the federal E-Verify program to verify the work authorization of newly hired employees. (North Carolina General Statue)

8. Notwithstanding anything to the contrary herein, in the event that public funds are unavailable and not appropriated for the performance of the County's obligations under this Agreement, then this Agreement shall automatically expire without penalty to the County 30 days after written notice of the unavailability and non-appropriation of public funds. In the event of a change in the County's statutory authority, mandate, or mandated functions by state or federal legislative or regulatory actions, which adversely affects the County's authority or duty to continue its obligations under this Agreement, then this Agreement shall automatically terminate without penalty to the County 30 days after written notice of such limitation or change in the County's legal authority or duty.

Reports prepared by the auditor shall be submitted to the Cherokee County Chief Financial Officer within 30 days of completion by the auditor and no later than 60 days before the end of the County's fiscal year(June 30).

At the expiration of the 72 hour period, the animals may be disposed of by VRHS as provided by law. North Carolina General Statutes § 19A-32.1

THIS LICENSING AGREEMENT (License) is made and entered into as of the ___day of ____ 2025 by Cherokee County (County), a body politic, and political subdivision of the State of North Carolina and MOUNTAIN YOUTH LIVESTOCK MARKET (MARKET).

CHEROKEE COUNTY SADDLE CLUB, INC. (Saddle Club) a non-profit corporation doing business in Cherokee County, North Carolina.

DECLARATIONS

WHEREAS, the County is the owner of the property commonly known as the Mountain Folk Center.

WHEREAS, the Saddle Club desires to make use of the Arena Facility and adjacent parking at the Mountain Folk Center to host equine-related events.

TERMS & CONDITIONS

WHEREFORE, Cherokee County, in service to its citizens, does hereby grant unto CHEROKEE COUNTY SADDLE CLUB, INC. a license to use the Mountain Folk Center facility as set forth on the attached map which is incorporated by reference, subject to the terms and conditions of this licensing agreement.

Term-This license is revocable at will, without notice by the County. The license shall commence upon execution and shall be durable until revoked by the county or revoked or abandoned by Saddle Club.

Remuneration: This license is granted without remuneration as the Saddle Club shall provide education and recreational opportunities to the citizens and visitors of Cherokee County.

Entry- Saddle Club is granted a license to enter into and upon the lands and structures set forth and described on the attached map. The County is under no obligation whatsoever to maintain the grounds of ingress, egress or regress to the facility.

Non-exclusive use – This agreement does not in any way, shape or form convey exclusive use nor any other property right to the facility. Saddle Club shall provide unto the County Manager desired dates for use of the facility, including rain dates and clean-up dates. The

County reserves the right to exclude Saddle Club or any other licensee from the facility at its discretion. County will endeavor to accommodate Saddle Club to use the facility for its scheduled events. The County Manager shall be the final arbiter of scheduling at the facility.

Alterations to facility — Saddle Club, nor its subordinates or associates, shall make physical alterations to the facility without the express written permission of Cherokee County. Any approved alterations must be accompanied by appropriate building permits and must comply with building codes of the State of North Carolina and Cherokee County. Any improvements on the property become the property of Cherokee County.

The parties agree that County shall be the owner of any improvements Saddle Club may make on or to the premises during the time this Agreement is in effect, if Saddle Club makes such improvements. Saddle Club shall have the same rights in and to such improvements as to the premises, with or without such improvements, under this Agreement. County, as owner, shall place insurance coverage on such improvements. Such insurance coverage shall identify Saddle Club as the loss payee so long as this Agreement is in effect.

Insurance – Saddle Club shall obtain special event insurance for a minimum of \$1,000,000 for each event and shall have Cherokee County named as "other insured". A copy of the policy shall be provided to the County Manager each year and a certificate of insurance for each event.

Hold Harmless- Saddle Club and any of its contractors indemnify and holds harmless, and shall forever defend Cherokee County for any damages or injuries incurred from their use of, ingress, egress or regress to said facility.

Acceptance- Saddle Club accepts the property subject to this license as is, where is. County does not warrant structural or operational integrity of the facility.

Assignment- Saddle Club shall not assign this licensing agreement to any persons for any reason and is not authorized to allow or sanction activities by any other person or persons on the subject property without written authorization by the County.

Maintenance-Saddle Club shall be responsible for:

- the removal of all trash and debris from the facility and the general cleanliness of the designated Mountain Folk Center facility associated with its events and use.
- -Saddle Club shall be responsible for routine maintenance of the facility including mowing, weed trimming and erosion control of the licensed area.
- Saddle Club shall leave the property in the same condition as they found it. Any damage incurred shall be reported to the office of the County Manager before vacating the property.

Saddle Club shall be responsible for all repairs for damages incurred associated with its events and use beyond normal wear and tear.

Trespassing- Cherokee County hereby authorizes the Saddle Club and its agents as users and possessors of the subject property, and are lawful occupants and persons in charge of the premises for purposes of any criminal trespassing statute under Chapter 14 of the North Carolina General Statutes and may issue orders to vacate the premises and to seek criminal process for violations of the Criminal Trespass laws of the State of North Carolina.

Designation of Document: This Licensing Agreement is a public record maintained by the County of Cherokee and bears the Seal of the County. Furthermore, this document is a business record maintained by Cherokee County in the course of its business as a body politic and subdivision of the State of North Carolina.

Withdrawal/ Abandonment- Saddle Club may withdraw from this licensing agreement at any time with written notice to the Office of the Cherokee County Manager any time.

On page 2 paragraph 3 of the agreement, CCSC agrees to strike the paragraph beginning "The parties...in effect."

On page 2 paragraph 10, we propose to remove reference to erosion control (or drainage). We do not believe that it is appropriate to use a licensing agreement that gives us access to the site at limited times and is subject to revocation at any time to require CCSC to perform construction projects. CCSC has already contributed \$9100 towards seeding the recently graded area. The drainage plan that is currently being developed addresses stormwater that flows over the entire Mountain Folk Center site. It is not possible to separate out the proposed horse arena area, which is downhill from much of the site.

The attached map includes the concessions building as licensed by CCSC. This building and its surrounds are managed by 4-H and not CCSC. The area indicated on the map should be taken out of CCSC's licensed area.

To Whom It May Concern:

This letter is to verify that the 2025 Property Tax Bill in the amount of \$\$1,622.29 paid by Vanderbilt Mortgage and Finance (on behalf of Deborah Huskins) was billed in error. This property contains (2) homesites, with Ms. Huskins only owning (and owing) for the mobile home located at 663 Canyon Road.

We have issued a release/refund request for the payment received by Vanderbilt on 08/29/25, check # 8207017 in the amount of \$1,622.29 and advised Ms. Huskins to contact her mortgage company to follow up on the refund.

We created (2) separate tax bills in lieu of the original 2025-8307. One for the amount of \$1,356.27 (for other homesite, located at 665 Canyon Rd.) and one for Ms. Huskins (\$336.02) for her mobile home, located at 663 Canyon Road. Moving forward, Ms. Huskins's tax bill should only reflect her mobile home, and any additions or out buildings she may add in the future – and no land value, as Ms. Huskins only holds a leasehold interest. Therefore, her annual tax bill due (based on her current taxable value) should be expected to be around the \$400 range, instead of the \$1,600 range.

Ms. Huskins paid her newly issued 2025 tax bill in full on 11/24/25. Please see attachments for reference.
